How to leave a gift in your Will

Types of Bequests

- Leaving a **percentage of your estate** means your gift will not be impacted by inflation and will have as much impact in the future as it would today.
- A **residuary bequest** is a gift of what remains after you have made provisions for your loved ones and any taxes and debts are settled.
- A **pecuniary gift** is a specific dollar amount.

Suggested wording to provide your Solicitor with when drafting or updating your Will:

I give *..... to Lifeline Direct Limited; registration is voluntarily transferred for general purposes. The receipt of the Chief Executive, Treasurer, and Secretary of the Public Officer for the time will be an absolute discharge to my executor(s).
